Guidelines Rules and Responsibilities

We are a Christian based program, and we will conduct ourselves in what we consider to be a Godly manner at all times. Sunday church is mandatory. Make sure you are up and ready by 7:15am. Disrespect of any kind will not be tolerated under any condition. Shirts and pants/shorts are ALWAYS to be worn inside the house. There is ASOLOUTELY NO profanity allowed at our home, at school or in our team vehicles. No vulgar music is to be played unless it is on your personal devices and in your headphones. No Horror movies are allowed unless they are played on your personal devices and in your headphones. Repeat violations of the guidelines will require a signed incident report and could lead to expulsion from the program at the discretion of GDPA Staff. Acts of community service will be required as a member of the Warrior Family. This may include moving boxes, cleaning yards, helping the elderly, washing team vehicles, participating in fundraising events etc. There are 2 Stores within walking distance. When going to the store make sure you have received permission from GDPA Staff and go with one of your teammates. There will be cameras located throughout the apartment for your safety and ours. If you are found in violation of our house rules, there will be consequences and possible expulsion.

We will be having guests, sponsors, and prospective players and parents come by unannounced and our home and apartment WILL BE PRESENTABLE AT ALL TIMES!

Personal Space

Please do not touch **ANYTHING** that does not belong to you. Violation of this rule will lead to immediate dismissal from the GDPA Program. **NO FIGHTING, BULLYING, HAZING, or INTIMIDATION OF ANY KIND WILL BE TOLERATED!** Violation of this rule will also lead to immediate dismissal from the GDPA Program. If you choose to bring game systems or personal items, GDPA will not be responsible for anything lost, broken, or stolen. There are **ABSOLUTELY** no visitors allowed in the apartment or on school/team property at any time without prior permission.

Kitchen/Lounge Area

This area is where you will spend most of your time. However, it is the first area seen upon entering the apartment. It is always expected to be cleaned and to be left **spotless** when you leave.

When finished eating, put your food containers in the trash immediately!

Clean your area and table with a wet wipe & dry it with a paper towel. Sweep if needed.

The refrigerator is to be always neat and clean.

Clear out all empty boxes and containers.

The microwave and air fryer are to be cleaned after each use.

ALL MEALS are to be eaten at the tables. (Only chips and water are allowed on the couch)

Colored drinks are not allowed in the lounge area.

There is to be **NO SLEEPING or Laying** on the couches, if you are tired, go in your room!

Do not have pencils or pens on the couches for any reason.

Absolutely **no sitting** on the arms of the couches

If you are wet or sweaty, **DO NOT SIT ON THE COUCH**

The trash is to be taken out at the following times:

8:15am (before school)

1:15pm (after school)

6pm (if we're not in the gym)

10:30pm (before bed)

***Additionally, if you see the trash is full, take it out!**

Bathroom

The bathrooms are a shared space and are to **ALWAYS** remain clean.

Wipe and scrub the toilet after **every use**. Also wipe the sink and counter **after every use**

No personal items are to be left in the bathroom at **(anything left, will be thrown away)**

Never overload toilet with tissue

Make sure the lounge area is clean.
Sweep and mop the floor (including under the table)
Vacuum and straighten the rugs.
Make sure there is no trash left on or under the couches.
Take out the trash.
Turn off the lights.

Food

Do not waste food. If you don't like it, let someone know.
Only eat what belongs to you. Taking someone else's food will not be tolerated.
You are responsible for your own food when you travel for basketball games and tournaments.

Bedroom

No eating in bedroom (only water)
Make sure that your area in the room is Always clean.
Make your bed every morning before leaving the room.
Beds that are not occupied are not to be touched.
Wash your bed linen every 2 weeks.

Laundry

Laundry will be done at the Laundry Mat on Friday Mornings at 9am. You will need money for the washer and dryer.
No one is to wash clothes here at the house.

Terms and Provisions
